on Following terms and conditions -

Once approved, after due inspection, the Society/Trust will not change any of the parameters claimed at the time of recog School Education Department Official can inspect school premises at any time. During inspection, if Society/Trust is found no following declared standard, then Divisional Joint Director can act as given is sub-rule(1) of the rule 11, and can suspend sch accreditation.
8. If school is not found to follow conditions and responsibilities given under Rule 5 and 9 as well as instruction and guidance by Department from time to time, the undersigned will have the power to suspend the school's recognition on the basis of investigation.
9. In case of any school Explanation Call, If the reply received from Society/Trust is not found to be satisfactory, then after gi hearing opportunity, the schools recognition can be canceled.

12. It will be mandatory to get affiliation with the Indian Certificate of Secondary Education, and follow all norms as given I M Affiliation by Trust.
13. In Case of any dispute, the jurisdiction of the Court shall be at Bhopal.
